Duplicate Degree/Diploma/Statement of Grades/Marks

1. A duplicate degree/diploma/Statement of Grades/marks is issued to the candidates in case of lost/destroyed/deface. The following documents are required to be submitted on e-mail examination@niu.edu.in or by hand in examination section:-

- (a) Application form (**Form-9**) duly completed and affixed self-attested latest photograph.
- (b) Payment receipt of Rs. 750/- (Rupees seven hundred fifty only) for each marks sheet and Rs. 2000/- (Rupees two thousand only) for degree. The fee can be paid in the university accounts office or online

or by any other online means available on the university website.

(c) Self-attested photocopy of any one of these documents (Aadhar Card, Driving License, Pan Card, Passport) as proof of identity.

(d) An attested copy of FIR lodged with the nearest Police Station to the effect that either the Original Degree/Diploma/ Statement of Grades/Marks has been irrecoverably lost or destroyed or defaced. If FIR available on website of the state, then self attested copy of its printout.

(e) Self declaration as per **Form-10**.

(f) Authorization letter (In case collected by others) alongwith ID proof of authorized person.

2. In case student requires duplicate degree/diploma/Statement of Grades/Marks by speed/registered post, postal charges will be paid by the student in addition to the duplicate Degree/Diploma/ Statement of Grades/Marks fee (Rs. 200/- within India and Rs. 2000/- for abroad). Address at which documents are required, must be neatly written in application form in CAPITAL LETTERS with correct PIN code.

3. In case of loss or any damage in postal, this university will NOT be responsible.

4. Minimum 30 days are required for processing the correction in degree and 07 days for correction in Statement of Grades/Marks after receiving the application.
