The University invites online applications from the eligible candidates for admission to doctoral (Ph.D.) Programme as per UGC Minimum Standards and Procedures for Awards of Ph.D. Degree Regulations, 2016 dated 05.05.2016 published in the Gazette of India dated 05/07/2016.

### **SUBJECTS OFFERED FOR Ph.D. PROGRAMME:**

Applications are invited for Ph.D. programmes for the session 2022-23 in the following departments of schools run by NIU:

1. **School of Engineering & Technology (SET):** Biotechnology, Civil Engineering, Computer Science Engineering, Electrical & Electronics Engineering, Electronics & Communication Engineering, Information Technology and Mechanical Engineering
2. **School of Liberal Arts (SLA):** English, Political Science, Sociology, Public Administration, International Relations, Geography, History and psychology
3. **School of Sciences (SOS):** Biotechnology, Microbiology, Chemistry, Physics, Mathematics, Computer Sciences
4. **School of Journalism & Mass Communication (SJMC):** Mass Communication
5. **School of Law & Legal Affairs (SLLA):** Criminology, Civil Law, Family Law, International Law and Human rights

### ELIGIBILITY FOR PH.D. PROGRAMMES

The admission to the Ph.D. programme would strictly be done on the basis of UGC Ph.D. Regulations 2016 and subsequent amendments dated 27th August and 16th October 2018. An applicant possessing any of the following qualifications shall be eligible to apply for admission to Ph.D. programme of the University:

1. **Master's degree or a professional degree** declared equivalent to the Master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate (50% for SC/ST/OBC {non-creamy layer}) or its equivalent grade 'B' in the UGC 7-point scale (or an equivalent grade in a point scale wherever grading system is followed) or an equivalent degree from a foreign educational Institution accredited by an Assessment and Accreditation Agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country for the purpose of assessing, accrediting or assuring quality and standards of educational institutions.
2. **A degree** considered equivalent to M.Phil. Degree of an Indian Institution, from a Foreign Educational Institution accredited by an Assessment and Accreditation Agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country for that purpose of assessing, accrediting or assuring quality and standards of educational institutions, shall be eligible for admission to Ph.D. Programme.



**DURATION OF PROGRAMME:**

Ph.D. Programme shall be for a minimum duration of 3 years, including course work and for a maximum duration of 6 years.

**EXAMINATION FORM AND FEES:**

Forms are available on the university website ([www.niu.edu.in](http://www.niu.edu.in)), which can be submitted along with Online payment or Demand Draft (in favour of Noida International University) of Rs. 1100/- latest by 10<sup>th</sup> August 2022. The applicant can download a copy of the submitted application form from the application submission portal and furnish hardcopy of the application form with photograph and all the documentary evidence in original (testimonials, certificates, publications, work experience and research/professional experience) at the time of interview.

**Incomplete applications will be rejected.**

**ADMISSION PROCEDURE:**

Admission to Ph.D. Programme shall be based on merit obtained in entrance test and interview.

The eligible candidates will be called for an entrance test on the notified date and time. Subsequently, a personal interaction with the expert panel will be held to judge the research aptitude in the candidate and also to consider applicant's proposed research area(s).

**SYLLABUS FOR ENTRANCE TEST:**

**Section A - Research Methodology and Aptitude** (Research Aptitude, General Awareness, Logical Reasoning, analytical Reasoning, Numerical Ability, English Language Statistics). (50% weightage)

**Section B - Subject Specific. (As per UGC/CSIR NET Syllabus)** (50% weightage)



The candidates who have qualified UGC-NET (including JRF)/ UGC-CSIR NET (including JRF/SLET/GATE) are exempted from written test and directly qualify for the interview.

**SELECTION CRITERIA FOR PH.D. CANDIDATES:**

1. Entrance test shall be qualifying with qualifying marks as 50%.
2. Final merit list will be prepared by adding marks obtained in the entrance test (70% out of 100 marks of entrance test and 30% mark to the interview obtained (as per latest UGC regulations).
3. Relaxation in entrance examination and merit list for qualifying the entrance examination would be given to the candidates (as per latest UGC regulations).
4. The interview will be based on allotment of marks as per the following criteria
  - The candidate possesses the competence for the proposed research
  - The research work can be suitably undertaken at the Institution/College
  - The proposed area of research can contribute to new/additional knowledge
